### **Registration for Summercamp 2020**

Summercamp 2020 is a 6 day event for hard of hearing young adults taking place at Mount Royal University in Calgary, Alberta Canada from August 9-15, 2020. This event will be accessible to all hard of hearing attendees with the provision of captioning/CART, a loop/and or DM systems as necessary.

Registration for Summercamp 2020 is limited and reserved by Country and Province. There are 50 Canadian and 25 International spaces allocated for this event. Canadian registration will be distributed to ensure a broad geographical representation of Canada is met. All registration forms must be completed in full and be accompanied by full payment of the registration fee. Should there be a reason your registration is not accepted by the Summercamp 2020 planning committee, you will be notified and receive a complete refund. All registration fees are quoted in Canadian Dollars (CAD) and payment must be received in Canadian Dollars.
